On 30 November 2020 key management personnel of Medusa Mining Limited were issued 83,000 Short Term Performance Rights (“PRs”).

The PRs have been issued in accordance with the terms and conditions of a Performance Rights Plan previously approved by Medusa shareholders on 28 January 2015.
